The Director, Directorate of Admissions, Osmania University welcomed all the members and invited suggestions from the representatives of all the Institutions/colleges conducting Special Education courses. Upon detailed discussions, the following resolutions are made regarding the admissions to be made into various courses conducted at NIEPID, AYJNISHD, Helen Keller's, Sweekaar, Swayamkrushi, Thakur Hari Prasad, Padmanayaka, Maa institute and Sahara Institute.

*The Director, Directorate of Admissions, O.U will announce the counselling dates for all the courses depending on the declaration of results of respective qualifying examinations in Telangana State.

- b. Due to Covid – 2019 depending on the situation prevails the Director, Directorate of Admissions will be take a decision regarding the entrances and admissions as per University / State Government directions.
- c. The notification issued by the institution / colleges has to be kept in Osmania website by paying the prescribed fee to Osmania University.
- d. The admissions will be based on entrance examination for all courses. However if the number of applications received is less than intake capacity then the admission will be finalized based on merit in qualifying examination and eligibility criteria.
- e. The results of entrance examination along with rank will be declared separately for Govt. Institutions/colleges(NIMH) and private institutions/colleges. Candidates qualifying the entrance exam for the Govt. Institute are only eligible for admission to Govt. Institute.

The candidates qualifying entrance for private institute are not eligible for Govt. Institution. However, the candidates qualifying the entrance for Govt. institute are eligible to apply for admission into private colleges subject to the availability of seats.

If the candidate apply to both institute then he will be given separate ranks for both institutes as per marks and position of the institute.

- f. All the Government National Institutes will issue separate national wide notification on their own to have wide coverage all over India. Remaining other colleges will issue separate notification on their own. The following points have to be mentioned in the notification:

1. Candidates appearing for the final examination are also eligible to apply for admission into the courses. However, the candidates have to produce certificates of declaration of results from the concerned University at the time of counselling, failing which admission will not be considered even though they have qualified in the entrance examination.
2. Admission will be based on entrance examination conducted by Osmania University. The Admission counselling will be conducted under the supervision of DoA, OU.
3. Private colleges have to notify that “The results of entrance examination along with rank will be declared separately for Govt. Institutions/colleges (NIMH) and private institutions/colleges by O.U. However, the candidates qualifying the entrance for Govt. Institute are eligible to apply for private college subject to the availability of seats at the time of counselling.” At the time of second counselling.
4. The Govt. Institute has to notify that “Admission into the courses will be based on entrance examination conducted by Osmania University and for the candidates applied in response to the notification issued by respective institute”.
